In the [redacted] my family moved to Elm Grove. We became members at St. Marys Parish. [redacted]

It was not long after this that I met Fr. Andrew Doyle. While my contact with Fr. Doyle was limited at first, our "friendship" grew stronger and closer in the following years.

I became more involved with different groups and spent more and more time at the church and rectory. Fr. Doyle encouraged me in these activities, and I began to attend meetings and other functions that kept me at the parish, sometimes quite late. It was these activities that allowed me to be gone at night for meetings without questions from my parents.

It was also these activities that allowed for Fr. Doyle and myself to spend time with other people, or to spend time alone. Our alone time was often spent at the rectory, sometimes we were the only ones (except for Maria the house maid) there, and sometimes the other two Mnsgr. Emenegger and Fr. Stommel were there also. I now find it odd that nothing to my knowledge was said. I firmly believe that they knew something was going on.

The first time Fr. Doyle and I had sex, was in his room at St. Marys. It was something that I was surprised by, during the preceeding year(s) unbeknownst to me this was the direction our friendship was headed. Looking back now, I don't see how it was not obvious to adults around the situation.

He used my confusion about to get what he wanted. Now his intrest in me, the late dinners, the golfing, and the

It began with him giving me a back message in his office. He asked if it felt good, it did, so I said yes. He said he could give me a better one if I were lying down, and suggested we go to his room. He had me lay down on his couch, the tan "L" shaped one

After more rubbing, kissing, and petting he suggested we move into his bedroom. He laid me down on the bed and took my clothes off. He started to masterbate me asking if I had ever felt this good before. I said no.

He then started to undress and suggested I help him to feel good. So I started to masterbate him. [redacted]

[redacted] I believe he said, "God love you."

He then placed me on top of him, putting his penis between my buttox and masterbated me untill I came. [redacted]

It was years before I realized I had been used, molested. How could he have done anything wrong? He was supposed to help. If

Then he was transferred to St. Mary's Hales Corners. He assured me however that we could still be together. He would be getting an apartment across the street, and it could be our meeting place. So our times together were now at his apartment. He said along with other reasons that he was getting it so we could be together alone.

He would not let me in the bedroom though unless he had first turned off the lights, and closed the curtains. This was just in case the associates were looking from across the street. If they were and saw, WE would get in trouble and it would be over.

Dear Andy,


Recently I was talking to Father Carrol Straub and he wanted me to put down on paper some kind of remarks about your status. First of all, Andy, I hope things are going well for you and that you have some peace of mind during this time. I know how important that is. I also hope that you are praying well and staying close to the Lord.

As I see it, Andy, these are the options open to you and what you have to weigh. If you wish to return to active ministry, I certainly would say a yes to that, but certain conditions will have to be in place. First of all, I would insist that there be some kind of ongoing psychological help. I also would insist that you remain a part of an AA program and that total sobriety be a part of your life. Secondly, wherever you would be assigned, I would have to make sure that there would be someone there who would be a kind of supervisor for you. In other words, I would have to let someone in those circumstances know of the previous accusation and, as it were, be a kind of supervisor in that regard. Number three would be that we would try to find a parish without a school and that there would be some kind of restrictions on your ministry to teenagers, especially private counseling. I believe, Andy, these are the things I would have to do in order to make sure that we have taken all precautionary measures that our responsibility demands.

If, on the other hand, you seek a permanent severance from the diocese, then I certainly would follow through on the financial promises that we made to you earlier on.

I hope you don't mind that I am sending a copy of this to Father Carrol Straub, since I know that he has been in touch with you and has been kind of a liaison. Blessings in abundance, Andy.

Dear Archbishop Weakland,

I was advised by Dr. [REDACTED] to prepare this request regarding my leave of absence, which I will formally present to you before announcing it to the parish on June 3rd, 1995.

As per our phone conversation, you agreed to grant me \$10,000.00 sometime on or before the 18th of June, 1995, my last day at St. Agnes. Also you agreed to continue my insurance for six months. I am thankful for both offers.

Regarding my leave:

I will not intend to publicly function in any priestly capacity. I will pursue gainful employment as quickly as possible. In as much as I only have a M. Div. to my credit, I don't expect any significant job offer.

If circumstances regarding the allegation do not change by the end of the six months, you had indicated that you would grant me an unspecified amount of money as a severance. Because I have regular bills and a house payment, I ask that if it becomes necessary for me to request a release from orders, at that time you would consider an amount of \$30,000.00. This would be taxable for me, but would allow me to pay off my mortgage. This is very important to me. I will have lost any security I now enjoy as a priest. I have tried to cooperate with the Archdiocese, and I ask this as a last chance to find a future outside the ministry, if it comes to that.

I regret any pain I have caused you; I also have been in much myself. I would appreciate an answer to this letter and my request as soon as you are able so that I may have some peace.

Dear Carol,

As you requested, I am writing this letter to indicate my decision to leave the active Ministry in the priesthood of the Catholic Church, and to reiterate the severance package agreed to by Archbishop Weakland in late April and again in his October letter to me.

I have found in the last 5 months that I made a mistake becoming ordained. Even though I did serve many well, I recognize that outside of the priesthood I can fulfill my personal development. I enjoyed many aspects of that life. I now look forward to enjoying my life, with the help of God.

As to the agreed severance package, the Archbishop indicated through you and to me directly that I would receive my portion of the retirement funds and the sum of twenty thousand dollars if I decided to not return after my leave of absence. This is what was agreed to after the Archbishop gave me ten thousand dollars for my leave of absence, without which I would not have been able to make it this far.

I would ask that one half be released to me before the end of 1995, and the rest shortly after Jan.1,1996. This is for tax purposes. My present job does not pay much, and the future of our business is somewhat shaky. This severance I believe is just and needed as promised.

I thank you for the manner in which I have been treated so far. I hope that my parting will still have us all give each other mutual respect. God bless you in your future.

4/5/84 - interview - A. Doyle is seen. Some of the reasons for the staff at St. Mary, Kenosha, refusing to accept him as AP were shared. Andy reports that many rumors are beginning to surface; several people have heard that he's being "disciplined", planning marriage, etc. Is told he probably won't be able to control the rumors. Is informed that G. Fleischmann would like to interview him for the AP position at St. Anthony, Meno. Falls. Will call George.

4/9/84 - telephone - Parishioner from St. Mary, Hales Corners, inquires into reasons for A. Doyle's transfer; he will be missed. Is explained that Andy was asked to consider a change because of needs in other parishes and needs of newly-ordained.

4/11/84 - interview - G. Fleischmann stops to state that he and A. Doyle have agreed that Andy can become AP at St. Anthony, Meno. Falls. Is asked to hold any announcements until the Board has a chance to discuss and vote on the proposal.
- telephone - A. Doyle reports that he has interviewed at St. Anthony, Meno. Falls, and both he and G. Fleischmann agree on his becoming AP at the parish. Is asked to refrain from any announcement until the Board can act on the recommendation. Effective date requested - May 1st.

12/17/84 - telephone - A. Doyle, St. Anthony, Meno. Falls, reports concerns for G. Fleischmann. There has not been much communication between the two recently, except George's informing Andy that he hopes to be reassigned in the near future. Andy not sure why this is happening; trying to find way to support George.

12/27/84 - interview - G. Fleischman, St. Anthony, Meno. Falls, is seen. George reports that he is interested in a change of assignment. Feels that A. Doyle is doing fine work and that he, George, has accomplished much in his four years at the parish. Believes it would be good for the parish if Andy stayed on and a new pastor came to the parish.

2/14/85 - telephone - A. Doyle, St. Anthony, Meno. Falls, inquires when G. Fleischmann will be leaving the parish. Reports that the parish has been told by George that he will leave by April or June. Andy also states that two priests have contacted him about the future opening.

3/4/85 - telephone - D. Filut, St. Thomas, Kenosha, reports continued interest in future opening at St. Anthony, Meno. Falls, but could not work with A. Doyle.

3/15/85 - telephone - A. Doyle, St. Anthony, Meno. Falls, inquires into possibility of applying for Pastorate of St. Anthony. Feels he should have a chance to learn administration. Is told that the parish is very large and perhaps not acceptable as a placement for a young pastor. Willing to act as Adm. Pro Tem if the position cannot be filled immediately; would appreciate that learning experience.

5/8/85 - telephone - M. Sablica calls to apply for Pastorate of St. Anthony, Meno. Falls; has helped out at the parish for some time and is willing to work with A. Doyle. Knows parish well; looks for guidance from Board.

6/24/85 - telephone - K. Schneider notifies T. Klink that he is free to contact and consult with staff at Meno. Falls, St. Anthony's. Tony reports he has already made an appointment with A. Doyle. Is aware that he takes over Aug. 1st.

6/26/85 - telephone - T. Klink calls to confirm that as of 8/1/85, he will assume the Pastorate of St. Anthony, Meno. Falls. He asks that when the announcement is made in the Herald, that the opening for a Team Member at St. Anne's also be open-listed. Is informed that this will be announced in Herald next week, July 1st wk. Tony reports this has been announced at St. Anne's already, and he will be meeting with A. Doyle and R. Gross on Friday and will ask them at that time to have the announcement made at St. Anthony's over the weekend.

6/2/92 - S. Krause calls to discuss her pain about the current situation at St. Agnes with the school board, council and Andrew Doyle. Andy is called and this information is shared with him.

6/15/92 - M. McCabe, Attorney, calls asking about his rights to confront Andrew Doyle and his decision about the St. Agnes school commission. He is put in contact with Don Lozier for the council issues involved.

8/11/92 - Andy Doyle calls regarding Bob Turner's health issues with stress. Bob seems to have difficulty with making decisions and this has affected his health.

3/9/93 - Periodic Review II is received for Andrew Doyle.

10/18/93 - [REDACTED], parishioner of St. Agnes, stops to discuss a situation involving Andrew Doyle and the payment of tuition at the parish school. The parish claims she missed a month's payment of \$126 in the Spring and has taken her to court to get her to pay what she owes.

11/30/93 - [REDACTED], parishioner at St. Agnes, calls with concerns about Andrew Doyle. She will write to Tom Venne.

12/17/93 - Andy Doyle is wondering if a decision has been made regarding the future of St. Agnes Parish in terms of being reduced to a one-priest parish. He had been called recently by T. Venne regarding the status of the parish.

9/2/94 - Andrew Doyle returns his evaluation for the extension of his term at St. Agnes.

9/22/94 - The Parish Council of St. Agnes returns the evaluation for the extension of Andrew Doyle's term.

10/12/94 - The Archbishop approves the extension of Andrew Doyle as Pastor of St. Agnes for six years.

1/5/95 - Andrew Doyle calls with concerns regarding Robert Turner. Bob has announced to the parish that he will be leaving the parish within two months to take an assignment in the Archdiocese. This is affecting the people at the parish and in Andy's mind also the coming budget for St. Agnes.

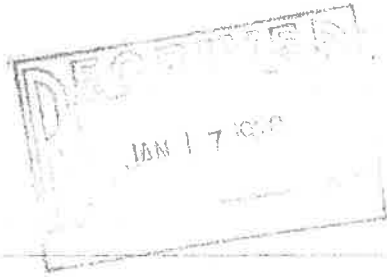
6/8/95 - Andrew Doyle calls inquiring about a T.A. for St. Agnes. He is leaving after the last mass on Sunday, June 18; requested priest help out beginning Monday June 19.

6/14/95 - Andrew Doyle is placed on personal leave effective July 1, 1995. He resigned his pastorate of St. Agnes on June 18th.

6/23/95 - The Archbishop responds to Andrew Doyle relative to his request for a personal leave. It was granted for six months beginning July 1st.

6/25/96 - Andrew Doyle is on permanent leave effective May 30, 1996.

STATEMENT OF RIGHTS AND OBLIGATIONS
INVESTIGATIONS INTO ALLEGATIONS OF MISCONDUCT

Whenever an accusation of inappropriate behavior is made, the Archdiocese of Milwaukee takes seriously its obligation to discover the facts, provide for protection of individual and communal rights, and encourage fulfillment of obligations. In that regard, whenever an investigation or evaluation is being conducted with someone accused of an offense, the following shall serve as guiding principles:

- 1) Professional evaluators conduct the evaluation using accepted evaluation tools of their profession;
- 2) The person being interviewed/evaluated is informed of the process to be used;
- 3) The person being evaluated/interviewed is informed regarding what information will be shared with whom and waives the expectation of confidentiality regarding the sharing of information with necessary persons.

Upon being notified that an investigation/evaluation is being undertaken the accused person should be informed of his/her rights. These rights include:

- 1) The right not to implicate oneself
- 2) The right to counsel, civil and canonical
- 3) The right to review the results of any evaluation
- 4) The right to know what has been alleged and to offer a defense against the allegations
- 5) The right to due process
- 6) The right to have the investigation conducted with discretion lest his/her good name be endangered by the investigation.

In addition to being informed about his/her rights, the accused person should also be informed of certain obligations such as:

- 1) The obligation not to interfere in the investigative process
- 2) The obligation to observe any special provisions imposed by the diocesan bishop.

Today I received a letter from [REDACTED] of [REDACTED] [REDACTED] letter details allegations against Fr. Andrew Doyle who is currently pastor at St. Agnes Parish, Butler. [REDACTED] alleges that Fr. Doyle sexually assaulted him in the late 1970's while Fr. Doyle was assigned to St. Mary's Parish, Elm Grove and St. Mary's Parish, Hales Corners. I advised Archbishop Weakland, Bishop Skiba, and Fr. Straub about these allegations.

3/15/95

I called [REDACTED] and left a voice mail message asking him to leave times when [REDACTED] would be available to talk with me about the details of his letter. I asked him to let me know on my voice mail of his age at the time of these allegations. [REDACTED] did leave a voice mail message late this evening advising me to call him on the morning of March 17. [REDACTED] also said that he was born in [REDACTED] and graduated in 1979 from St. Mary's School in Elm Grove. He was "14 or 15" at the time he alleges Fr. Doyle's abuse began.

3/17/95

I did speak this morning with [REDACTED]. He reiterated what he had alleged in his letter to me. [REDACTED] said sexual contact happened a number of times when he was between the ages of "14 or 15" and "17ish." [REDACTED] claimed that he met with Fr. Doyle in October of 1994 and that at that time, Fr. Doyle told [REDACTED] he had gotten help. Fr. Doyle also reportedly told [REDACTED] that "it" should never have happened in the first place and that "it" had happened in Fr. Doyle's family when Fr. Doyle was younger. [REDACTED] said he was coming forward mainly to be sure that "Fr. Doyle is not still doing this." [REDACTED] said he needs some closure on the whole matter. [REDACTED] also said that this matter "has always bothered him."

[REDACTED] also said that he believed Msgr. Emmeneger, Fr. Stommel, and Dan Schroeder (an ex-priest of the Archdiocese) could have known something about this matter since he believes they would have seen him in Fr. Doyle's presence. [REDACTED] told his parents of the situation in October 1994. He said his father told him of an incident in which his father alleges that Fr. Doyle came to the family's door one evening and said "I need a drink."

[REDACTED] also said that he believed Msgr. Emmeneger, Fr. Stommel, and Dan Schroeder (an ex-priest of the Archdiocese) could have known something about this matter since he believes they would have seen him in Fr. Doyle's presence.  Father George Zwadzich informed me that he is very concerned about Doyle's drinking. At one time Doyle admitted that he was an alcoholic. Now he continues to drink socially and word is getting back to Zwadzich about how Doyle behaves when he is drinking. It seems there is a personality change. Zwadzich told me that he is going to monitor the situation more closely but seems to think that the time for outside intervention is growing near. 4/12/82
830. Doyle, Andrew
 His brother [REDACTED] ([REDACTED], home; [REDACTED], office) called me from Minneapolis to express some grave concerns for his brother. [REDACTED] claims that Andy has a serious drinking problem that is apparent to the family for some time now. He said that his concerns can be corroborated by all the other members of the family especially his sister, [REDACTED] and his mother who lives at [REDACTED]. [REDACTED] is a recovering alcoholic himself and claims that he can recognize the problem in others. In his brother he sees some very erratic behavior that he feels is linked up with a drinking pattern. We talked for a long time and then I told him that I wanted to look into this further on the local scene and that I would follow up even to the point of treatment if this is necessary and warranted. That evening I spoke to Father Barbian privately and asked if he had any observations along this line. He told me that he had some problems with Andy's behavior but that he could not link this up with alcohol because he thought that Doyle is now drinking less than he had in the past. Barbian admitted that there have been some blowups and that he would not be surprised if Doyle sought another assignment. 9/7/83

 His sister, [REDACTED] ([REDACTED]) called to continue the conversation of her brother, [REDACTED], a few days ago. She related one event that occurred within the last month when she came to Milwaukee and was picked up at the airport by her brother and [REDACTED]. She said that one wife and she could tell that both of them had been drinking heavily, and it was nine o'clock in the morning. They explained to her that they had been partying on some parishioner's "martini boat" until 6:00 a.m. She said she told them both that they were out of line. She said that it looks like [REDACTED] is a drinking partner of her brother but she does not want to say or do anything to get him in trouble. She said that all she wants is to see her brother get some help. 9/9/83
837. Doyle, Andrew
 His mother called me [REDACTED] rather upset because she had heard from her brother [REDACTED] that there was going to be a big confrontation of Father Andy on the day of his brother's wedding. I told her I had no knowledge of that and assured her that there was no need for this at that particular time. I told her that other members of the family had expressed their concern for his health and she concurred that he is in trouble and needs some help perhaps even treatment for alcoholism. I assured her that I would work toward that end after her son's wedding. Both Doyle's brother, [REDACTED] and his sister, [REDACTED] told me that Father Doyle was footing the bill for his brother's wedding which meant that he had to be going into debt for this. 9/12/83

Doyle, Andrew

His brother [redacted] called from their brother's wedding reception at the Timber's here in Milwaukee. [redacted] and his sister, [redacted], feel that the occasion is inappropriate to come and see me and discuss their problem with Andrew's drinking. They feel that he is headed toward behavior that will give him away and cause others to take note and intervene. I told [redacted] that before Andy got into an accident or did something foolish, I would like to warn him that his family feels this way and also ask him to get a professional evaluation of his drinking. [redacted] felt this was a good idea and told me that I had permission to say that he and [redacted] had been in contact with me.

His sister, [redacted] called to say that she knows I have confronted Doyle with some of their concerns because he called her very upset and feeling that she had betrayed him. She still feels very strongly that there is a drinking problem and also a problem with the way he manipulates people. She is in the process of writing him a letter trying to explain the way the family perceives his behavior. Later I spoke to [redacted] who said that he has met with Father Doyle and suspects there may be a problem with alcoholism. He said that Doyle's principal problem, however, is his manipulation of others and the fact that he gets himself into more trouble by doing this. He will continue to meet with Doyle for the present and does not know if the Wausau evaluation would be helpful at this point. I did not ask [redacted] whether we should get Doyle into treatment at Guest house yet.

[redacted] tells me that the family of Father Doyle is tremendously mixed up and that the farther he stays away from the family the better off he is going to be.

Later [redacted] told me that Doyle had been in to see him. He did not discuss the issue but he said that Doyle was uptight. [redacted] said that this last week five priests came to see him. On Monday evening January 8, 1990 I spoke with Andy by phone, reviewing the history of the current problems at St. Agnes and strongly urging that he slow things down considerably.

On Thursday, January 17, 1991 Andy called the office to seek assistance regarding an accusation from a parishioner who is a lawyer and member of the parish athletic board to the effect that Andy had been removed from St. Mary's in Elm Grove because of a paternity case. Sister Rose transferred him to the offices of Joe Dean and Joe Perry.

284. Doyle, Andrew
On Monday, March 11, 1991 Andy called to say that he was undergoing surgery that same day for [REDACTED] and would be out of commission for approximately two weeks, adding that Erv Mogilka will cover the parish in his absence. RJS

On Tuesday, March 19, 1991 Andy called to inform us of a [REDACTED] surgery scheduled for Friday, March 22, 1991 and to request assistance during Holy Week. RJS
349. Doyle, Andrew
On Monday, March 25, 1991 I received a phone call from Erv Mogilka who is helping out at St. Agnes Parish in Butler repeating the strong lecture given to Andy about absenting himself from Holy Week Services in order to have the benefit of recuperation as prescribed by his doctor.

On Tuesday, March 26, 1991 I spoke with Andy regarding his [REDACTED] problems and his need to be serious about full recuperation even if it requires several weeks of confinement to a wheelchair. RJS
701. Doyle, Andrew
On September 29, 1992 Andy Doyle called regarding a friend of his who is in advertising. He has been asked to design an ad for a law firm seeking clients who have been abused by priests indicating the Catholic Church has deep pockets. Andy recalled Archbishop Weakland remarking that the priest was the responsible part. I told Andy we use that as our defense and it has been successful, but not all cases and Dioceses have been successful in this defense. Andy also mentioned he will be having surgery Oct. 14 to [REDACTED] from his previous operation. RTV

On October 7, 1992 I spoke with Andy who was on a private retreat at his cottage. My concern was to summarize the information which had been presented to me by the delegation at the end of August, namely that Andy's tithing principle was driving the financial management of the parish, that he was at times perceived as agreeing to a follow-up procedure but changing the rules in mid-term if he suddenly had a better idea and that those who disagreed were treated as enemies. Andy stated that there had been a fine parish retreat some two to three weeks ago and that he was himself convinced of the healing process. He underscored the presence of Ed Pronley as a driving force behind any group that would come to the Archdiocese. I think the conversation was thoughtful and helpful. RJS

Andy would be happy to have Bob as an Associate for 2 more years during his incardination period. Andy feels they work well together, and believes he has helped Bob to grow slowly in a more collaborative ministry. Bob does like meetings and Andy will continue to work with him to see their importance in Parish ministry today. He also feels that Bob is slowly growing in a less clerical style for Liturgy.

Doyle continued to counsel him and put his arm around him for reassurance. Now the man is claiming that Doyle made a homosexual pass at him. He spoke to the youth minister of the parish who recommended he see her friend Father Charlie Walter. Walter came to see Doyle and Doyle explained the whole situation. Doyle then called [redacted] and [redacted] told him to speak to me. I told him I thought Walter would be in a position now to counsel the young man that he was misinterpreting the whole situation. I said to have Walter call me if necessary. Doyle knows that he used extremely poor judgement in allowing the young man to sleep over on those occasions.

However, the man is sticking to his story and claims that he and Doyle attended the PAC last month and had alcoholic drinks before and after the event. It was on the way home that Doyle, he claims, made another pass at him. Walter is most concerned about the drinking because Doyle is constantly speaking in front of groups of people especially young people and telling them how his parents were alcoholics and how he became an alcoholic but now has the matter under control. He intends to confront Doyle with this matter.

I request a duplicate copy of a Rescript issued by your office in 1996.

Recently the Reverend James E. Connell, my Vice Chancellor, conducted a review of the files concerning priests of this Archdiocese who have petitioned the Holy Father for a dispensation from all obligations related to Holy Orders, including celibacy, so as to be able to be returned to the lay state. While in general the files are in proper condition, the status of one file raises a significant concern because the Rescript from the Holy See is missing.

In 1996, the Holy Father granted to the Reverend Andrew Patrick Doyle a dispensation from all his obligations arising from his priesthood ordination (Prot. N. 1289/96/S). Andrew was notified about the dispensation and he happily accepted the news. In addition, Andrew's baptism record has been properly annotated.

Now, however, the actual Rescript received from the Holy See cannot be located. Father Connell has reviewed all the files trying to locate the document, but to no avail. He is embarrassed by the situation and acknowledges that he might have inadvertently discarded the document in the trash.

In any event, I request a duplicate copy of this Rescript so that the file here will be complete.


I write this letter to ask you for a dispensation from the obligations of priesthood ordination, including celibacy, so that I may return to the lay state. My reasons are deeply felt and are arrived at with great thought and prayer.

I entered the seminary at age 14. I am now 46. All during my early childhood there was tension at home between my parents, resulting in seven separations of their marriage. Both parents were addicted to alcohol, and my mother was clinically depressed. It was from this family background that my father took me to apply for the seminary. He had done the same thing to my oldest sister in taking her to the convent, which she left some years ago. She was dispensed from her vows. The poor example of relationship and commitment I saw as I grew made me fear closeness, yet I yearned for it as time went on.

I recognize deeply my need for intimacy and companionship. The vow of celibacy would remain impossible for me and, as my history of infidelity to that vow even to the years in priesthood would attest to, I would be put in to grave temptation if this dispensation is not granted. This is an admission I should have made prior to ordination, but was afraid to admit to family and friends.

I prayerfully ask you to dispense me from the obligations of priesthood, including celibacy, so that I may return to the lay state. I ask for your prayers as well.

May I respectfully submit to the judgment of the Congregation for Divine Worship and the Discipline of the Sacraments the attached petition of the Reverend Andrew Patrick Doyle, a priest of the Archdiocese of Milwaukee, to be reduced to the lay state and dispensed from all obligations attached to sacred orders, including that of celibacy.

The following is the preliminary information and background relative to the petition of the Reverend Andrew Patrick Doyle. He very seriously desires to be dispensed from the obligations of the priesthood. However, this case is not without potentially great scandal due to his continuing sin against the sixth commandment of the Decalogue, which also stands as a crime against c. 1395, §1. In short, in June of 1995 Father Doyle confessed to maintaining a homosexual relationship which he and his partner consider a permanent union. While the Most Reverend Rembert G. Weakland, O.S.B., the Archbishop of Milwaukee, would be willing to handle this matter in a penal process if no other solution can be found, Father Doyle does not want the embarrassment of a penal procedure and thus freely seeks a dispensation from the Holy Father. In other words, this petition attempts to diffuse calmly a potentially scandalous situation.

Actually, once this situation came to light, and in the hope that with counseling and spiritual guidance Father Doyle would repent and again become available to priestly ministry, Archbishop Weakland granted Father Doyle a leave of absence. However, the Archbishop and I must now conclude that no practical hope remains for Father to cease this homosexual relationship and return to active priestly ministry. Fortunately, Father's situation has not become known publicly, other than among a few persons. But I have a concern that at some time in the future the presence of scandal in the community might develop because of Father's actions, and I believe the Church must be able to say that we responded properly and at the right time.

Also important in this case is that a different incident of sexual misconduct by Father Doyle was brought to Archbishop Weakland's attention in March of 1995 when an adult man contacted the Archdiocese of Milwaukee to report that in 1982, while this man was then a minor, Father Doyle had sexual contact with him. Archbishop Weakland immediately arranged for counseling for this man and no civil legal action seems to be developing in this matter, at least for the present. Of course, Archbishop Weakland had no choice but to place Father Doyle on an administrative leave of absence (c. 1722) while this allegation was investigated.

Then, while the investigation process was underway, Father Doyle acknowledged his current and ongoing homosexual relationship. Moreover, Father indicates that he and his partner consider themselves in a committed relationship, and that they have no intention to terminate it (see questions 14 and 23 of the petitioner's testimony where Father states these facts). I believe, therefore, that Father Doyle's confession not only truly presents the reality of an ongoing sin against the sixth commandment, but it also indicates a crime against c. 1395, §1.

As I have said, Archbishop Weakland and I had hoped that Father Doyle would reconsider his decision, repent, reform, and eventually return to active priestly ministry. Yet the opposite seems to have happened. Father Doyle no longer communicates with us nor with the Instructor of this case, Fr. Connell. In fact, while two persons have provided testimony for this cause, two other persons, although indicating that they would cooperate, have not furnished testimony, and Father Doyle refuses to intervene and assist in obtaining their input. Simply stated, he has become uncooperative.


In fairness to Father Doyle, I must say a few words about his very difficult childhood and young adult years. Both Father's mother and father were alcoholics, and his mother also suffered a serious mental illness. In fact his parent's marriage was marred by many separations and financial problems. As a child, Father Doyle lived in fear of his father and probably entered the seminary at age fourteen in order to escape from the family problems. Since he had not learned to trust his parents when he lived at home, as a seminarian Father was unable to trust the faculty. Thus, as he became confused about his sexual orientation and his sexual experimentations with both males and females, Father was unable to seek necessary advice and counseling. Then, as he entered priesthood and began to fail in his commitment to celibacy, he continued to face life without obtaining competent help.

Now that Father Doyle's reality has become known to at least some Archdiocesan officials, Father desires to depart from the priesthood so as not to compound his lack of integrity. So, in an effort to avoid any further humiliation, Father freely petitions the Holy Father for a dispensation from all priestly obligations, including celibacy, so that he may return to the lay state.

Believing that Father Doyle is firm in his conviction to continue living in this homosexual relationship and in an effort to avoid a penal procedure, I support his petition as the way to avoid serious scandal and to bring forth justice. Consequently, I now submit this cause.

Dear Bishop Sklba,

The instruction of the case of the Reverend Andrew Patrick Doyle, who wishes to petition His Holiness, Pope John Paul II, for a dispensation from the obligations arising from sacred orders, including that of celibacy, so that he might return to the lay state, is now complete. As you had mandated, the instruction was carried out in accordance with the Procedural Norms issued by the Congregation for the Doctrine of the Faith in 1980 (Prot. N. 128/61).

Although Father Doyle initially cooperated with the efforts of this cause, his willingness to assist quickly ceased. In particular, when I met with Andy to accept his petition letter to the Holy Father and to take Andy's testimony, Andy identified four persons who would provide witness testimony. However, only two of the four persons has provided information so far, and Andy has not responded to my requests for him to encourage the other two persons to contact me. I have both spoken to Andy on the telephone and I have written to him, but to no avail.

Nevertheless, given Andy's confession to a continuing sin against the sixth commandment of the Decalogue, which also would be a crime against c. 1395, §1, and also given his unwillingness to terminate this relationship, I do not consider the processing of this case without the testimony of the two potential witnesses to endanger Father Doyle's rights in any way. On the contrary, charity and justice require that the cause move forward so that scandal can be avoided.

Andy grew up in a very troubled family. Both his mother and father were alcoholic, and his mother also suffered from a serious psychiatric illness and would leave the family for lengthy periods of time. In addition, according to Andy, his parents separated seven times during their marriage. As a result, not only did the family frequently experience financial problems, Andy lived in fear of his father and entered the seminary as a boarding student to get away from the general state of chaos at home. Furthermore, although his mother never went to church and his father did so rarely, Andy found his parish priests to be a source of peace and happiness. So his desire to enter the seminary, while an escape in one sense, also was a reasonable decision.

During his college seminary years, Andy left the seminary for one year, expecting to marry a woman he had been dating. However, soon after his departure from the seminary, the idea of marriage evaporated, and the following academic year Andy returned to the seminary to continue preparing for the priesthood. During his seminary years, Andy seems to have developed the ability to present a public persona that is different from his actual or private persona, especially regarding sexual matters. More specifically, during this time he experimented sexually with various persons, both male

and female. Not only did he hide from himself his trauma within, he kept secret from the formation faculty of the seminary his inability to develop the discipline to live a celibate life.


Apparently, during his years as a priest the dual life continued. In fact, in 1995 an allegation of sexual misconduct with a minor boy many years earlier, while Andy was in his first priestly assignment, was brought against Andy. Furthermore, as this situation was being investigated, Andy acknowledged that he has been living a sexually active life, while also functioning as a parish priest. In fact, presently he is in a homosexual relationship, which has been going on for a few years and which he and his partner consider a permanent union. Indeed, since Andy has no intention of terminating this involvement, here is the essence of Andy's continuing sin against the sixth commandment of the Decalogue and crime as stipulated in c. 1395, §1. In fact, Andy confesses to this sin and crime in questions #14 and #23 of his testimony, the transcript of which Andy signed in my presence.

Now that this aspect of his history and his true current situation have come to light, Andy feels that, for his own integrity and for the good of others, he must separate from the priesthood. Thus he willingly seeks from our Holy Father a dispensation from all his priestly obligations, including celibacy, so that he might be returned to the lay state.

In my judgment, although a few priests and a few members of the laity know the truth about Father Doyle, no real scandal seems to have arisen, at least not as of this time. Hence, not only because the Code of Canon Law expects that a penal procedure be used only if other solutions prove fruitless (cf. c. 1341), but also because the introduction of a penal procedure against Father might actually create scandal simply because more persons would become aware of the happening, I would encourage you to forward this case to Rome. Hopefully, Pope John Paul II will agree that a dispensation quietly granted would be better for the Church than a penal process. However, in the event that the Holy Father concludes that a dispensation would be inappropriate, then I would recommend that a penal procedure be introduced in our Tribunal, because, if at some time in the future the truth of Father Doyle becomes generally known and if the Church had not responded appropriately for the good of the people, I would expect that a serious scandal would arise at that time. So, this petition for a dispensation, freely requested by Father Doyle, is an attempt to prevent scandal while also serving justice.

Hence, I now present the case to you for your consideration.





1. Andrew Patrick Doyle, West Bend, Wisconsin, USA;
I am employed as a customer service representative for an employment agency in Milwaukee.
2. December 8, 1949 in Milwaukee, Wisconsin.
3. My father: Andrew P. Doyle; Catholic; deceased.
My mother: Helene Smith Doyle; Catholic; deceased.
4. Incardinated in the Archdiocese of Milwaukee.
5. Baptism: January 8, 1950; Confirmation: October 26, 1961.
6. a) My parents' marriage was a shambles. They were separated seven times in a 43 year marriage. This was also due to both having alcoholism and my mother's psychiatric problems.
b) There are six brother and sisters in my family.
c) My relationship with my parents was not very good. We children lived in fear of the next time my father and mother would separate and leave, or of the insanity that would develop with alcohol.
d) My mother hardly attended church, and my father talked about the Church but had little close connection with it.
e) My oldest brother left home when I was four. My next oldest brother was sent away from home because of his behavioral problems. He eventually spent ten years in prison. My oldest sister was taken to the Sinsinawa convent by my father because he felt she was taking care of his younger children and that this was interfering with the need for my mother to develop into a caring parent. She eventually left the order years later. My next oldest sibling sister was not around much, which left myself and my youngest brother to stay at home with parents who were deteriorating both physically and emotionally.
f) My father made good money but it was spent on many hospitalizations for my mother's addiction to drugs. We lived as a family beyond our means, which meant that there was little left at the time of my father's death.
g) I attended St. Robert's grade school for two years, then I attended Holy Family school for two years, then I returned to St. Robert's for three years, then graduated from St. Cecilia's parish school. These changes in schools were due to my father's "escape" from the bad memories associated with homes we left.
h) I had no dating experience before I entering the seminary.
7. My first recollection of the desire to become a priest was Fr. John F. Murphy telling me after serving Mass for him. I really consulted with no one. My father took me to the seminary to apply the same way he took my sister to the convent. I now see that it was a way to get me away from the craziness at home. Neither parent really spent any time encouraging me. This was because at the time their marriage was so unsettled that they only were thinking of their own pain.

8. My studies for the priesthood began in 1964 at De Sales Preparatory Seminary in Milwaukee, Wisconsin. I stayed for seven years and then left to be married.

9. I left to marry a young woman whom I had been dating as a seminarian. We had met through a retreat program in which we worked together. However, soon after I left the seminary, she decided to call off the engagement and we stopped dating each other. I attended Cardinal Stritch College for one year. Then I returned to St. Francis Seminary.

10. I was ordained a deacon on December 8, 1975 at De Sales Seminary Chapel. I was ordained a priest in St. Eugene Parish Church on August 27, 1976.

11. I was sexually active early in my seminary training. My spiritual director was a kind man, but he should have encouraged me to leave and find my growth as a person outside the seminary. There was experimentation with both sexes.

12. There was no undue pressure to become ordained. Quite frankly, I had started something and was now too close to the end to leave even though I should have.

13. The seminary had regular religious exercises which I attended. I know that the inner struggle that I was ignoring about my need for intimacy overshadowed the religious activity.

14. The obligation to celibacy was explained, but I ignored my sexual history in favor of hoping the drives and orientation would be overcome by the grace of ordination. This orientation would eventually develop into some homosexual relationships, including the one I am presently involved in. In fact, this current relationship has a commitment which I would not want to break. He and I consider this a life-long decision to remain together.

15. My concept of priesthood changed mostly through internal growth changes rather than anything precipitated in the Church. As personal honesty became more necessary for me, the internal struggle between who I was and who I had to be as a priest was taking a great psychological toll on me.

16. I had no hesitation to receive orders because it was a goal I had struggled to reach for so long that I was so close to completion I could not walk away.

17. Yes.

18. Associate Pastor of St. Mary Parish, Elm Grove, WI: September 7, 1976 - June 15, 1981;

Associate Pastor of St. Mary Parish, Hales Corners, WI: June 16, 1981 - April 30, 1984;

Associate Pastor of St. Anthony Parish, Menomonee Falls, WI: May 1, 1984 - November 29, 1988;

Pastor of St. Agnes Parish in Butler, WI: November 30, 1988 - July 1, 1995 at which time I began a personal leave.

19. At times it was very rewarding. To be used as a tool of God for forgiveness was very fulfilling. To bring hope to people through homilizing was also wonderful. The politics of the local parish began to take their toll on me. The infighting and obstructionism on the part of "leaders" in the community of the parish became unbearable. This is when the need for another human being in my life became intensely obvious.

20. If you were to ask the vast majority of priests and parishioners who know me, I would never be described as a slouch.

21. I have always had a devotion to the Eucharist. I spent many hours in prayer before the Blessed Sacrament. I did lose faithfulness to the recitation of the Rosary.

22. The priesthood changed during my training and with it the expectations. I know that deep inside me was the hope that the ministry would take away my loneliness. It didn't.

23. The failure to be able to live up to the vow of celibacy was something that I struggled with constantly until I came to the conclusion that God had made me with my being who I am. I didn't choose my orientation. Who would? I then came to the belief that God accepted me the way He made me. I also did not and do not accept the official teaching of the Church on homosexuality. Actually, during the last ten years or more I have been in various homosexual relationships and I judge that there is nothing wrong with this life style. My current partner and I have made a real and lasting commitment to one another.

24. I shared this struggle with five priests who are still my friends.

25. No.

26. I cannot live two lives any more. My personal integrity requires that I depart from the priesthood.

27. I was granted a six month leave of absence from Archbishop Weakland beginning July 1, 1995.

28. I sought professional counseling through the years and they all indicated the resolution would be to leave for better mental and physical health.

29. I have no long-range plans, and certainly not for marriage.

30. I have been working for an employment agency, and I live in an area where I am hardly known.

31. There has been no negative effect on my co-workers.

32. I am morally certain that I cannot continue to function as a priest.

33. [REDACTED] have known me for almost my whole life.

34. I wish to add nothing.

35. I swear before God that my answers are true.

A. Family Background

1. We DoYLES saw ourselves as a middle, or upper middle-class family. Our dad had a Law degree from Marquette and was Vice-President of Sales at Briggs and Stratton; our mom was a refined, well-read lady. We were raised very proud of our Catholic, Irish background, and lived either across the street from, or within a few blocks of, the parish church. The Parish life and our Catholic education were very important.
2. I am the first daughter, and middle of six children. Andy was born when I was 11; I was delighted, and became his care giver whenever I could. Our relationship has stayed very close over the years.
3. There is a 17 year gap between our oldest brother and our youngest brother. The oldest had gone into the Army before Andy was even a toddler. With parents whose relationship was troubled, we 6 children watched out for each other and stuck together pretty tightly.
4. Our family was thrilled when Andy entered the Seminary; it had been his dream since early childhood. As a family, we went to any celebration or special seasonal Mass of Andy's. This has continued from Ordination to the present.

B. Previous to Ordination

1. There was nothing to cause question or doubt about the future.
2. When Andy was 7, I entered the Dominican Order; I wasn't home to watch his behavior;
3. We six children were raised in deep emotional situations. I often think how amazing it is that we reached adulthood as functional and wholesome as we did. Can you tell me the correct way to respond in "deep emotional situations"? Maybe then I could answer you.
4. Andy has always been unusually thoughtful and generous.

C. Ordination Time

1. Andy was very anxious to fulfill his dream of being a priest.
2. He certainly seemed at peace with his decision.
3. Andy was very enthusiastic.
4. Andy's basic maturity, goals, and value system seemed as sound as any priest's I've ever met, and then some.

Andy is so warm, I don't know any priest who comes near with such compassion or selflessness. Do you?

I had no privy to the religious background other than that they seemed to be devoted Roman Catholics.

2. Andy is my brother-in-law by my marriage to his sister [REDACTED]
3. My observation was one of concern, being available and willing to help them in their needs. Andy was very proud of his family, and always made sure they were introduced to his parishoners or fellow priests at festive occasions.

4. The family was always proud of Andy, and supported him in his religious formation.

The only negative things were his mother's constant illness, and her constant fight against addiction to drugs and alcohol. The family was always alert to her needs, and helped however they could to overcome this terrible addiction, which she fought all her life.

B. Previous to Ordination

1. Because I came into the family as Andy was almost finished with his studies, I was not aware of any of these items.

C. Time of Ordination

- 1.Andy seemed excited and ready to save the world.
- 2. He seemed very settled and at peace.
- 3. Andy exhibited extreme enthusiasm.
- 4. He seemed ready to go and start working.
- 5. There were no apparent negative or unpleasant pressures.

D.After Ordination

1.Andy seemed to enjoy ministry. At times he had his ups and downs with his superiors; but these were no different from what other members were experiencing with their work or business.

- 6. Yes, his rectories were happy places.
- 7. Andy seemed to compromise to resolve conflicts.
- 8. Andy was always appropriate.
- 9. The people always told of how happy they were to have Andy. His services were always to a full church, and the people showed their respect with their handshakes and hugs. They sure seemed to like him. He is an extraordinary preacher!

SETTLEMENT AGREEMENT
AND MUTUAL RELEASE

This Settlement Agreement and Mutual Release (hereafter "Agreement") is made by and between Andrew P. Doyle and the Roman Catholic Arch/diocese of Milwaukee (hereafter "Arch/diocese"), and all of its affiliated entities.

WHEREAS, Andrew P. Doyle has determined to seek voluntary dispensation from priesthood in the Roman Catholic Church under certain conditions as more specifically set out below; and

WHEREAS, the Archdiocese is willing to accept Andrew P. Doyle's decision to seek dispensation from the priesthood in the Roman Catholic Church, and in reliance on that resignation is willing to agree to the terms set out below; and,

WHEREAS, Andrew P. Doyle and the Archdiocese wish to settle and compromise all claims that either of them may have against the other, and wishing to accomplish the complete and total separation of Andrew P. Doyle from active priestly ministry in the Roman Catholic Church;

NOW, THEREFORE, in consideration of the mutual promises herein provided and other valuable consideration, receipt of which is hereby acknowledged, the parties to this agreement hereby agree as follows:

1. The Arch/diocese agrees to provide Andrew P. Doyle the sum of (\$20,000/ \$10,000). This sum is payable upon an answer from Rome that Andrew P. Doyle's request for dispensation from his obligations as a priest of the Roman Catholic Church has been granted. If the answer from Rome is that Andrew P. Doyle's request is not granted, then Andrew P. Doyle agrees to stipulate to a finding from the Archdiocese of Milwaukee that he is impeded from performing the functions of a priest of the Roman Catholic Church, and he will not oppose such a finding. In that event, the (\$20,000/\$10,000) will be paid to Andrew P. Doyle upon entry of an uncontested finding by the Archdiocese of Milwaukee that Andrew P. Doyle is impeded from performing any functions of the Roman Catholic priesthood. All parties will bear any and all costs and attorney fees associated with this settlement.

2. Andrew P. Doyle is currently entitled to a severance reimbursement from the Archdiocese priests' pension fund. This reimbursement will be paid to Andrew P. Doyle pursuant to a letter from him directing how these funds are to be paid, so long as consistent with the rules of the plan.

3. In return for the financial consideration set out above, and for the mutual promises contained herein and for other good and valuable consideration, receipt of which is hereby acknowledged, Andrew P. Doyle agrees to release and forever discharge the Roman Catholic Archdiocese of Milwaukee, and all of the Archdiocese's employees, agents, officers, directors, and assigns, including, without limitation, all members of the Roman Catholic clergy, and all parishes and schools, and any person or entity affiliated with the Roman Catholic Church in the territory of

the Archdiocese of Milwaukee from, and covenants not to sue them for, all claims, causes of action, charges, and demands, whether in tort, contract, or otherwise, of any nature that he may have had at any time up to and including the date of signing of this Agreement, including without limitation any claim of any nature arising from any entitlements he could assert from having been ordained a priest in the Roman Catholic Church. By signing this Agreement and attached letter, Andrew P. Doyle agrees to seek dispensation from his obligations as a priest in the Roman Catholic Church, agrees to sign the documents necessary and to cooperate in the proceedings necessary to seek approval from Rome to have himself dispensed from the priesthood of the Roman Catholic Church; in the event that Rome does not approve his dispensation, to stipulate to a declaration by the Archdiocese of Milwaukee that he is impeded from the exercise of all functions as a priest in the Roman Catholic Church, and to not contest any proceedings necessary to a declaration that he is so impeded; agrees never to function within or outside the Archdiocese in any capacity as a priest nor to seek reactivation in priestly ministry at any time. He further agrees to give up any claim or entitlement that he may have to any benefit, compensation, support, or other attribute of the priesthood, other than as specifically set out in this Agreement. He further agrees not to perform any of the functions of priestly ministry, including without limitation, administering the sacraments and the celebration of Mass, and in no respect will he hold himself out as a priest in the future.

4. The Archdiocese and all of its affiliated entities hereby release and forever discharge Andrew P. Doyle from all claims, demands, and causes of action of any nature that they may have had up to any including the date of the signing of this Agreement.

5. The parties agree that this Agreement is not an admission of liability on the part of any party.

6. The parties agree not to disclose to any third party, including, without limitation, any newspaper, any electronic media, any reporters, or to release for publicity any of the provisions of this Agreement. Failure on the part of Andrew P. Doyle to abide by this provision will result in action for repayment to the Archdiocese of financial considerations provided.

7. The Archdiocese agrees that if in the future Andrew P. Doyle is sued for sexual abuse by any individual, the Archdiocese will apply to him whatever policy is then in effect for reimbursing inactive priests for attorney's fees in defense of such claims. Under no circumstances, however, will the Archdiocese indemnify Andrew P. Doyle for any judgment or settlement amount in connection with such claim.
