The collection consists of correspondence, minutes of unit meetings, “Deo Gratias” newsletters, etc. of an organization affiliated with the Apostolate of Suffering. The Good Samaritan Guild was composed of Catholic women engaged in the corporal work of mercy visiting the sick and handicapped in the Archdiocese of Milwaukee.
